- And we had discussion yesterday. This violates
- 25 the rules. We're supposed to be voting at this time. I

- 1 would like for the membership to proceed to vote.
- 2 DEPARTMENT TREASURER TELLYER: I move to cap it
- 3 to \$1,000.
- 4 JUNIOR ACTIVITIES CHAIR ROMANO: You can't make a
- 5 motion when it's closed already. We are -- we're in the
- 6 process of voting. We need to vote.
- 7 DEPARTMENT PRESIDENT SCHULTZ: Motions can be
- 8 amended.
- 9 JUNIOR ACTIVITIES CHAIR ROMANO: The maker of the
- 10 motion has the final say. I was the maker of the
- 11 motion. I've already ended, and I'm not accepting a
- 12 friendly amendment.
- DEPARTMENT PRESIDENT SCHULTZ: Okay. The motion
- 14 has not been decided yet.
- 15 JUNIOR ACTIVITIES CHAIR ROMANO: I call for the
- 16 question. The motion has already been made. It's
- 17 automatically seconded by the direction of the
- 18 committee. We had discussion.
- 19 DEPARTMENT PRESIDENT SCHULTZ: Calling for the
- question has to be seconded. Is there is a second?
- 21 UNIDENTIFIED SPEAKER: Second.

  Calling for the question means no one can discuss it

  That's what calling for the question means. I move to

- 10 Chairman understands the importance of befriending the
- 11 staff of their local newspaper Connect. They had
- several articles published on their Girl State delegate
- and an article showcased their scholarship awarded in
- 14 the amount of \$1,000. PR chairman Mary had articles
- published in July, October, November, and December and
- 16 also last May.
- 17 Stephanie Huff, District 18 PR Chairman reported
- 18 their Past District President, District President, First
- 19 Vice President, and Poppy Chairman go to Disneyland and
- 20 pass out pens to the veterans in attendance during the
- 21 retreat ceremonies.
- 22 Public Relations Chairman Lorrie Lewellyan,
- 23 District 19 reported Lakewood Unit 496 has no chairman,
- but this doesn't stop them from getting the word out.
- 25 They belong to their Chamber of Commerce. They attend

events where they represent the Auxiliary sharing
information with local business owners and residents of

1 Legionnaire from District 11's wife made it for Glenda. 2 And it's beautiful. 3 (Applause.) 4 EDUCATION CHAIR HAYES: Beautiful, beautiful 5 auilt. I was pretty sure that ticket said "Linda 6 Hayes." 7 8 **EDUCATION CONVENTION REPORT** 9 10 EDUCATION CHAIR HAYES: Okay. The convention 11 committee on Education -- the convention committee on 12 Education met on June 17th, 2024 via Zoom at 5:00 p.m. 13 The statistical report of this Chairman appears on page 14 29 in the Book of Reports. Carolyn Glenn, Unit 92, 15 District 2 was the appointed secretary, Barbara Toth, 16 Unit 299, District 25 offered prayer, and Teresa Nunez, 17 Unit 628, District 17 was appointed sergeant-at-arms. 18 A total of 18 District delegates answered roll 19 call and there were 12 visitors present. The committee 20 agreed on the following report. The committee 21 recommended the following changes to Education Code. 22 Department Code No. 12 to become No. 13 and add No. 12. 23 "Deadlines for scholarships are: No. 12 reads: 24 A. Scholarships offered by Department. 1. Each Unit

- 20 By the direction of the committee, I move to
- 21 accept these -- this new code.
- 22 DEPARTMENT PRESIDENT SCHULTZ: We have a motion
- on the floor for Education Department Code No. 12 to
- 24 become No. 13.
- 25 EDUCATION CHAIR HAYES: Okay. Just read this

- 1 part.
- 2 DEPARTMENT PRESIDENT SCHULTZ: Okay. Sorry. We
- 3 have a motion on the floor to change Department Code 12
- 4 with an addition. If adopted it will read: "Deadlines
- for scholarships are: A. Scholarships offered by
- 6 Department. 1. Each Unit will select one applicant for

- or before March 1st. (2024). 2. National will forward
- applications to the Department Chairman. (2024). 3.
- 21 After judging, the Department Chairman will select the
- top three applicants for each type of National
- 23 scholarship and forward them to the Western Division
- 24 Chairman on or before April 1st. (2024). 4. Winners
- will be notified by National. (2024)."

- 1 Is there any discussion? 2 (No response.) DEPARTMENT PRESIDENT SCHULTZ: 3 Hearing none, 4 we'll vote. All those in favor. 5 ALL DELEGATES: Aye. 6 DEPARTMENT PRESIDENT SCHULTZ: Opposed. 7 (No response.) DEPARTMENT PRESIDENT SCHULTZ: Motion carried. 8 9 EDUCATION CHAIR HAYES: Thank you. Is that 10 better? Okav. So by direction of the committee I 11 propose that -- okay. Department Code No. 13 reads: 12 "In June 1991, the Ganey Family presented the Department 13 of California a gift of \$5,000 to establish a Memorial 14 Scholarship in honor of their mother, Past Department 15 President Lucille Ganey. The Ganey Family specified 16 that the scholarship be granted to a California student 17 attending Stephens College one \$500 scholarship to be 18 awarded annually. Since the Ganey Family did not 19 specify the scholarship to be awarded to a veteran's 20 child, grandchild, or great grandchild, donations to 21 this scholarship cannot be made from the Poppy Funds. 22 Any donations to the Lucille Ganey Memorial Scholarship 23 must be made from the General Fund and should be 24 earmarked specifically for the scholarship.
- 25 If adopted this Code No. 13 will be deleted

- 1 because the Ganey Scholarship has never been -- there's
- 2 never been an applicant. There are no family members
- 3 that are known to the American Legion Auxiliary left to
- 4 contact and there's no longer a Ganey Scholarship line
- 5 in the budget. I move that we delete the current No. 13
- 6 from the Department Code.
- 7 UNIDENTIFIED SPEAKER: Second.
- 8 DEPARTMENT PRESIDENT SCHULTZ: There's a motion
- 9 to delete Code No. 13 under the Education Code. Is
- 10 there any discussion?
- 11 DEPARTMENT PARLIAMENTARIAN BIGGS: Anita Biggs,
- 12 Past Department President. If we delete this code where
- will there be any reference to the scholarship in our
- 14 documents? Where will we know that the funds for
- 15 Lucille Ganey has been moved to the General Fund? Is it
- 16 going to be in another code? Where is there reference
- anywhere that the monies that we're just taking the
- money out completely and -- there's no money? Oh, I
- 19 thought there was money. Are we positive there's no
- 20 money?
- 21 FINANCE CHAIR WORKMAN: Madam President, no one
- 22 has applied for the Ganey Family Scholarship in years,
- years, years. I can't even remember back, and let me
- tell you I've been around for a long time. No one has
- ever applied for it. It has to be a California student

- 1 going to this certain school in Missouri for journalism
- 2 and no one has ever applied for it, so it's just been
- 3 sitting there.
- 4 DEPARTMENT PARLIAMENTARIAN BIGGS: There's money.
- 5 FINANCE CHAIR WORKMAN: There's money in that
- 6 Poppy donation whatever that's been sitting there.
- 7 DEPARTMENT PARLIAMENTARIAN BIGGS: So we're just
- 8 going to move it over.
- 9 FINANCE CHAIR WORKMAN: Yeah.
- 10 DEPARTMENT PRESIDENT SCHULTZ: Is there any
- 11 further discussion?
- 12 (No response.)
- 13 DEPARTMENT PRESIDENT SCHULTZ: Hearing none,
- 14 we'll vote. All those in favor.
- 15 ALL DELEGATES: Aye.
- 16 DEPARTMENT PRESIDENT SCHULTZ: All those opposed.
- 17 (No response.)
- 18 DEPARTMENT PRESIDENT SCHULTZ: Motion carried.
- 19 EDUCATION CHAIR HAYES: Okay. So we'll be
- 20 renumbering for the addition of No. -- a new No. 12 and
- 21 deleting the current No. 13. And there are also
- 22 household -- household -- housekeeping changes.
- The Unit Second Place Supplemental report was

- 9 EDUCATION CHAIR HAYES: And then the second
- 10 Educational Assistance application for \$1,000 was won by
- 11 Noah Kwanoski of Unit 52 in District 28.
- 12 (Applause.)
- 13 UNIDENTIFIED SPEAKER: 152.
- 14 EDUCATION CHAIR HAYES: Oh, okay, Unit 152. The
- 15 Scholarship for Continuing or Reentry Students was won
- by Madison Ammirati from Unit 292, District 5.
- 17 Congratulations to all the winners.
- 18 Closing prayer was offered by Barbara Toth.
- 19 Madam President, may I continue with my platform
- 20 remarks?
- 21 DEPARTMENT PRESIDENT SCHULTZ: Yes, you may.
- 22 EDUCATION CHAIR HAYES: Okay. This year's Board
- of Education has worked hard to get out the Education
- 24 information to the Units and it shows. I would like to
- share with you some impressive work the Units have done

- 1 this year. For instance, the total donation amount for
- 2 the Give 10 to Education program was \$44,204. Besides
- 3 the usual paper, pencils, pens, folders, backpacks,
- 4 crayons and notebooks, Unit 302 donated 150 laptops to
- 5 local schools and another Unit donated \$300 for
- 6 backpacks with school supplies. And one Unit purchased
- 7 T-shirts with an anti-bullying logo on it and Stop
- 8 Bullying cards.
- 9 For National Education Week, Unit 14 held a
- 10 crossover event with the American -- Americanism Program
- 11 named "American as Apple Pie" which I reported on at
- 12 DEC. And what impresses me the most is that everyone
- 13 attending the event received fliers with instructions on
- 14 how to sign the Pledge of Allegiance. Unit 79 donated
- 15 playground games and exercise equipment.
- 16 Units promoted scholarships by discussing
- 17 scholarship opportunities with Girls State delegates,
- 18 local colleges, and local high schools. They sent
- 19 letters to school counselors. Links to the application
- were emailed to high schools. Flowers were handed out.
- 21 Articles were sent to newspapers and qualifying junior
- 22 members received scholarship information.
- Units reported on their Veterans in the Community
- 24 School Project. One unit invited a female veteran to
- 25 share her experiences. She spoke about her military

- 1 service and what it was like to be one of the first
- 2 females to serve aboard a Navy ship. She brought her
- 3 memory books to share with the students. The students
- 4 asked her how to join the military after graduation.
- 5 Unit 716 had three veterans visit school campus
- 6 and interact directly with students, sharing stories and
- 7 experiences and answering questions from students.
- 8 There are many impressive things our Units have
- 9 done that deserve recognition. I can talk for an hour,
- 10 and I know I don't have that kind of time.
- 11 DEPARTMENT PRESIDENT SCHULTZ: Not if you want to
- 12 get installed.
- 13 EDUCATION CHAIR HAYES: Units have given out
- 14 local scholarships totaling \$38,450. And I already said
- who the Department recipients were.
- The Department received 53 Children of Warriors
- 17 applications, five nontraditional and one Spirit of
- 18 Youth scholarship application. Winners, California
- 19 winners are Lindsay Carstairs, Western Division Children
- of Warriors Scholarship for \$5,000. Bailey Haywood won
- 21 the National Spirit of Youth Scholarship for \$5,000.
- 22 And because Bailey won her scholarship, California will
- also receive \$1,000 for our scholarship program.
- 24 (Applause.)
- 25 EDUCATION CHAIR HAYES: Out of, what, four

- 1 different divisions of scholarships and we had three
- 2 winners from our state.
- 3 (Applause.)
- 4 EDUCATION CHAIR HAYES: Okay. The National
- 5 Nontraditional Scholarship was not the National winner,
- 6 but is a winner in our eyes. Jessie Castillo was the
- 7 first place department winner and won \$500.
- 8 I want to thank Suzanne Baker and Rebecca Glenny
- 9 for taking the time to read and judge 59 scholarship
- 10 applications. Fifty-nine. As you can imagine, it was
- 11 grueling work and it took hours, but they made my job
- 12 easy because believe it or not, they independently chose
- the same top winners.
- 14 Madam President, may I hand out my awards? Okay.
- 15 Should I go down there to do it?
- 16 DEPARTMENT PRESIDENT SCHULTZ: Ladies, come on
- 17 up. Not you again.
- 18 EDUCATION CHAIR HAYES: Okav. First Place for
- 19 the District Supplemental Report goes to Molly Smith
- 20 from District 828.
- 21 (Applause.)
- 22 EDUCATION CHAIR HAYES: And then First Place Unit
- 23 Supplemental goes to Unit 392 Rodi. Rodi.
- 24 (Applause.)

- 12 continue with my First Place Americanism Essay winners?
- DEPARTMENT PRESIDENT SCHULTZ: Yes, you may.
- 14 AMERICANISM CHAIR ROGERS: Group 1 4th and 5th
- 15 grades, first place goes to Ian Arias, District 4, Unit
- 16 98 awarded \$100.
- 17 (Applause.)
- 18 AMERICANISM CHAIR ROGERS: Group 2 6th and 7th
- 19 grades, first place Aniyah Rose Jones. Aniyah? Is that
- 20 how you say it? Sorry. Unit 98, District -- Unit 4 --
- 21 District 4, Unit 98 awarded \$100.
- 22 (Applause.)
- 23 AMERICANISM CHAIR ROGERS: Okay. Group 3 8th
- and 9th grade first place, Larrissa Gomez, District 20,
- 25 Unit 348 awarded \$200.

- 1 (Applause.)
- 2 AMERICANISM CHAIR ROGERS: There you go. Okay.
- 3 Group number 4 10th and 11th grade first place goes to
- 4 Hunter Gomez, District 20, Unit 384 awarded \$500.
- 5 (Applause.)
- 6 AMERICANISM CHAIR ROGERS: Are you here? Oh,
- 7 yep. Okay. And group 5 students with special needs,
- 8 first place goes to Elijah Lopez, District 28 -- or 27,
- 9 Unit 457 awarded \$200.
- 10 (Applause.)
- 11 DEPARTMENT PRESIDENT SCHULTZ: Cindy, before you
- 12 continue with the rest of your report, we need to take a
- 13 five-minute pause. So everybody please don't leave, but
- 14 you can talk.
- 15 (Recess from 10:47 a.m. to 10:50 a.m.)
- 16 DEPARTMENT PRESIDENT SCHULTZ: Okay. Ladies, our

- 8 AMERICANISM CHAIR ROGERS: The Americanism essays
- 9 will be posted in the Convention Office afterwards.
- 10 Madam President, can I continue with my report?
- 11 DEPARTMENT PRESIDENT SCHULTZ: Yes. Yes, you
- 12 may.
- 13 AMERICANISM CHAIR ROGERS: Thank you, Madam
- 14 President, for giving me this Americanism appointment.
- 15 Thirteen districts participated in Get the Vote Out
- 16 Campaign, thirteen districts promoted the district Essay
- 17 Contest, and 26 essays were received. Six districts
- 18 promoted the National Essay and six were received.
- 19 5,527 and 44 certificates were presented to residents
- and/or businesses.
- 21 Nineteen districts promoted daily flying of the
- 22 American flag. Eighteen districts promoted patriotism
- in our schools. Twenty-two districts participated in
- 24 holiday events. 15,627 flags were handed out and 7,482
- 25 flags placed on grave sites. Twelve districts supported

- 1 the Legion Baseball and Oratorical Contest. Sixteen
- districts educated students in proper display/retirement
- 3 and -- of the flag. Twenty-two Gold Star and 27 Blue
- 4 Star Banners were given to military families. Fourteen
- 5 districts delivered the flag etiquette brochures to
- 6 schools. Ten districts promoted the Star Spangled Kids
- 7 program with 350 Star Spangled Kids kits were
- 8 distributed. Twenty districts participated in Wreaths
- 9 Across America. A total of \$24,208 was spent or donated
- to purchase 6,767 wreaths and 10,284 wreaths were laid
- 11 to rest.
- District 28, I'd like to mention, Unit 589 had
- been supporting the Veterans' Day Parades for 13 years,
- and this year Unit 81 stepped up to help.
- 15 (Applause.)
- 16 AMERICANISM CHAIR ROGERS: However, this year was
- 17 special. It was the first time with --
- 18 DEPARTMENT PRESIDENT SCHULTZ: Excuse me. Just a
- 19 second, Cindy.
- 20 Ladies, if you're going to talk in the back, go
- 21 talk outside. Please go out.
- 22 AMERICANISM CHAIR ROGERS: However, this was the
- 23 first -- however, this year was special. It was the
- 24 first year with a float. One of the members' father had
- 25 made a picnic table for the back of the float for the

- 1 members that were not able to walk this year, but
- 2 unfortunately he passed suddenly and was not able to be
- 3 here. The family came together to fulfill his dreams.
- 4 They had a poster-size photo of one of the veteran
- 5 members who recently passed away on the side of the

- Members supported military service members and their families this year by welcoming home and sending off 3,050 soldiers. Units spent \$20,334 putting together over 45 care packages.
- 5 The mission of Comfort, Hope and Promises, which 6 was founded by a member of Unit 222, is to provide moral 7 support to our deployed troops through care packages and 8 supporting soldiers' families at home. Unit 222 9 supports this organization through monetary donations. 10 They spent several months selling handmade fabric 11 Christmas stockings to raise money to purchase more 12 fabric, treats, and cards and to defray costs of 13 shipping.
  - Unit 222 sent 1,035 stockings to troops serving overseas and across the country. They also helped stuff 5,000 stockings at Christmastime.

In December 12 members of Unit 552 partners with the Pacific Beach Women's Club and held a Whoville holiday extravaganza for 46 activity duty families.

They bought commissary gift cards for each family, had games, food, and fun. Santa and the Grinch were both present. Members spent over 200 hours and \$3,000 in support of this event. Additional gift cards and goody bags were donated to the San Diego Military Outreach Mission for their holiday campaign for active duty

- 1 families.
- 2 Travis Air Force Base is located within our 5th
- 3 District. They held a ceremony at the Vietnam Memorial
- 4 in Vacaville. Three Unit members provided over 30 hours
- of help and planning time for the ceremony. Units
- 6 donated money to ensure successful outcomes. They had
- 7 approximately 150 attendees which included leadership
- 8 from Travis Air Force Base, elected officials, and
- 9 former POWs and their families.
- 10 Unit 302 is made up of mostly veterans, active
- 11 duty, and their families. This year they lost seven
- 12 veterans to suicide. This Unit made sure to recognize
- the families and offer them a purple banner. They also
- worked with the families through the grieving process.
- 15 They had two PTSD and trauma debriefing therapists who
- 16 are regularly out helping soldiers and their families
- 17 through free counseling sessions.
- Damn you, Rodi. Sorry. You made me cry and
- 19 cuss. Good thing my kids aren't here.
- 20 Unit 283 had a Spirit Walk. The unit handed out
- 21 T-shirts to participants in support of National
- 22 Security. After the hike members attended a luncheon to
- show support for former POW Jessica Lynch. She spoke
- about her experience and her rescue.
- 25 One unit in District 27 invited forty 9th graders

ı	to a mock military funeral. Students rearried now to
2	unfold the American flag, why it was laid on the casket,
3	what a 21 gun salute was, how to fold the American flag
4	and how to present the folded American flag to the
5	family of the deceased soldiers. Four junior members
6	and two senior members made 40 poppy wreaths which each
7	student placed on a deceased military grave after the
8	cemetery.

- 5 to pick up your 100 percent reporting after my report.
- 6 Got lots of fun stuff here, ladies.
- 7 The preconvention meeting for the Poppy program
- 8 was held at the Visalia Convention Center in the Kaweah
- 9 A Room at 9:10. The start time was delayed
- 10 accommodating members who were coming from the DEC
- 11 meeting that was running late.
- 12 Alberta Cummings, District 23, was appointed
- 13 secretary, Sandy Felix, District 14, was appointed
- 14 chaplain, and Rosemary Barron, District 28 was appointed
- 15 sergeant-at-arms. Roll call showed 20 delegates and 12
- 16 guests in attendance.
- 17 The Pledge of -- the chaplain offered prayer and
- 18 the Pledge of Allegiance was recited. The statistical
- 19 report for this program can be found in the convention
- 20 Book of Reports on page 34.
- 21 The committee agreed upon the following report:
- Department code was read. Addition to Poppy Code 7a to
- read: "Poppies shall be ordered in groups of 25 with 25
- being the minimum number allowed to be ordered.
- 25 (2024)."

- 1 The rationale is that poppies are bundled in
- 2 groups of 25. It is not realistic to accept orders for
- 3 ten or 15 poppies. By direction of the committee, I
- 4 move to accept this addition to the Poppy Code.
- 5 UNIDENTIFIED SPEAKER: Second.
- 6 DEPARTMENT PRESIDENT SCHULTZ: We have a motion
- 7 on the floor for Poppy Code 7a. If adopted it will
- 8 read: "Poppies shall be ordered in groups of 25, with
- 9 25 being the minimum number allowed to be ordered."
- 10 Is there any discussion?
- 11 (No response.)
- 12 DEPARTMENT PRESIDENT SCHULTZ: Hearing none,
- we'll vote. All those in favor.
- 14 ALL DELEGATES: Aye.
- 15 DEPARTMENT PRESIDENT SCHULTZ: Opposed.
- 16 (No response.)
- 17 DEPARTMENT PRESIDENT SCHULTZ: Motion carried.
- 18 POPPY CHAIR FALKENBERG: Thank you. Now we have
- 19 housekeeping. So the current --
- 20 DEPARTMENT PRESIDENT SCHULTZ: You don't have to
- 21 read housekeeping.
- 22 POPPY CHAIR FALKENBERG: Okay. I was just going
- to say it's a relettering and then we just had some
- 24 punctuation that had to be fixed.
- 25 One also that I should mention was Poppy

- 1 Production No. 8, California Veterans Home at Yountville
- 2 has been removed. It does not change the meaning of the
- 3 code. Yountville does not participate and has not
- 4 participated for years. Our Past Poppy Production
- 5 Manager has noted that it's been years so we removed
- 6 Yountville from any Poppy production.
- 7 Following after this, the floor was opened for
- 8 discussion and suggestions. Some of the discussions
- 9 included --
- 10 DEPARTMENT PRESIDENT SCHULTZ: Okay. Excuse me,
- 11 Robin. That --
- 12 POPPY CHAIR FALKENBERG: Is that a code change
- 13 just moving it? Okay. My apologies. So by direction
- of the committee I move that Poppy Production Code No.
- 15 8 to remove "California Veterans Home at Yountville" is
- the only change to the code. I do not have the full
- 17 reading in front of me. I just thought because it was a
- 18 remove, it was a housekeeping so I apologize.
- 19 DEPARTMENT PRESIDENT SCHULTZ: Anita has the
- 20 code. Hold on just a minute.
- 21 POPPY CHAIR FALKENBERG: Yes, please, Anita.
- Thank you.
- DEPARTMENT PARLIAMENTARIAN BIGGS: Code 8 Poppy
- 24 Production Code currently reads: "A year-round poppy
- 25 production is authorized at the California Veterans

- 1 Homes at Yountville, WAVE Clinic San Diego, and Long
- 2 Beach VAMC to give veterans the opportunity to
- 3 participate in the therapeutic and incentive work
- 4 programs without the pressures of a short-term
- 5 production."
- 6 POPPY CHAIR FALKENBERG: By direction of the
- 7 Poppy preconvention committee, I move for the change of
- 8 that code.
- 9 UNIDENTIFIED SPEAKER: Second.
- 10 DEPARTMENT PRESIDENT SCHULTZ: We have a motion
- on the floor Poppy Code No. 8 to remove "California"
- 12 Veterans Home at Yountville."
- 13 Is there any discussion?
- 14 (No response.)
- 15 DEPARTMENT PRESIDENT SCHULTZ: I don't even want
- 16 to say all those in favor because I loved it there and
- 17 they did such great work. I'm sorry. All those in
- 18 favor.
- 19 ALL DELEGATES: Aye.
- 20 DEPARTMENT PRESIDENT SCHULTZ: Opposed.
- 21 (No response.)
- 22 DEPARTMENT PRESIDENT SCHULTZ: Motion carried.
- 23 POPPY CHAIR FALKENBERG: I concur, Madam
- 24 President, it's very sad to lose a Poppy production.
- 25 It's just -- that concludes my committee report. May I

- 1 continue with my floor remarks?
- 2 DEPARTMENT PRESIDENT SCHULTZ: Yes, you may.
- 3 POPPY CHAIR FALKENBERG: Thank you, ma'am. The
- 4 Department of California, aka Department of Forestry,
- 5 has been very busy cultivating poppies throughout the
- 6 Golden State this past year. In all the 220 units
- 7 throughout the state ordered a total of 143,374 poppies.
- 8 (Applause.)
- 9 POPPY CHAIR FALKENBERG: Thank you. That is a
- decrease from 2,000 from last year, but I know my
- 11 numbers may differ from Ms. Liz's numbers due to the
- 12 fact that we both are supposed to get copies of the
- orders and some of us they didn't.
- 14 I will -- let's see here. Additional orders were
- 15 placed and some units did not submit their orders by the
- deadline. I will be recommending next year's Poppy
- 17 Chairman to not allow flexibility in ordering. Every
- 18 late order means an adjustment to the supplies that need
- 19 to be ordered. If units want their poppies in a timely
- 20 manner, make sure your orders are in on time, plain and
- 21 simple. I will say no more about that at this time.
- 22 Many units have conducted various activities to
- include mailing out self-addressed envelopes with a
- 24 poppy and a donation letter. Other units had poppies
- 25 available at community events as well as information

- 1 about the poppy and the poppy story. Other members have
- 2 poppies available at bingo nights, church craft fairs,
- and even provided poppies to veterans at a local Stand
- 4 Down. We had unit members handing out poppies at the
- 5 local farmers market and several units hand them out at
- 6 their annual Memorial Day and Veterans Day ceremonies at
- 7 their local posts and parks, other units at their local
- 8 veterans building.
- 9 There were poppy quilts, such as the one that was
- 10 just won at the back of the hall, as well as corsages
- and boutonnieres for special events and ceremonies,
- 12 poppy Christmas ornaments and so on and so forth.
- There are so many more examples of how the
- 14 American Legion Auxiliary members promote the poppy and
- the Poppy program. We would be here all day and many
- 16 more hours if I were to mention them all. I just want
- to say a special thank you for all you do to promote the
- 18 poppy program.
- 19 Don't all districts and units have donated funds
- to a local -- some of them, excuse me, not all.
- 21 Districts and units donate to a local food pantry that
- serves homeless and at-risk veterans and they covered
- the costs of turkeys and ham during the holiday season.
- Another unit raised over \$2,000 from their poppy
- 25 mailing.

1 During the COVID shutdown, many units were not

2 able to work the poppy program as they had in the past.

- 3 They found new and inventive ways to share this
- 4 information with their communities. As most of the
- 5 poppies are made by hospitalized veterans, the number of
- 6 veterans participating in the poppy production has
- 7 decreased. Our Department has had to have units and
- 8 districts help with poppy production to meet the needs
- 9 of the unit. Thank you.
- During the shutdown, our Department lost a couple
- 11 poppy production sites, so filling the orders was a
- 12 challenge. Our Department Secretary reached out to
- other departments to fill our orders. She was amazing.
- 14 Thank you, Liz.
- 15 Also thank you to those districts and units who
- 16 made poppies as well as the units who donated their
- existing extra poppies -- thank you, 694 -- to ensure we
- were able to fill the orders. You know who you are and
- 19 I greatly appreciate your willingness to help. We are
- also working on getting additional poppy production
- facilities up and on board for the coming year.
- District and units, please consider joining the
- poppy production program. The more hands we have doing
- the work, the lighter the work will be. Please reach
- out to your 2024-2025 Poppy Chairman if you would like

- 1 more information.
- 2 Two of our districts submitted entries for our
- 3 Poppy poster competition. There was some amazing
- 4 artists participating this year. Thank you so much for
- 5 sharing your talents with the Department of California
- 6 and our nation. Good luck on the National level.
- 7 And a side note, I had framed copies with me to
- 8 bring and a couple of the frames got broke, so I will be
- 9 taking those with me to Clovis to present to Madam
- 10 President Glenda.
- 11 As far as our Poppy Display and our Poppy Hat
- 12 competition, thank you to all who took the time to
- 13 create these awesome works of art. I appreciate your
- 14 adhering to the guidelines and the rules. It is
- 15 extremely painful for a chairman to have to disqualify
- an entry for not following those guidelines. You all
- made my job much easier with your compliance.
- When it comes to judging the displays and those
- 19 hat entries, I recused myself from judging as I knew
- there were entries from my own district. I did not know
- 21 which ones this were, but I did not want any appearance
- 22 of impropriety. Thank you to the volunteer judges. It
- was a pleasure to work with you.
- 24 The second and third place winners for both the
- 25 displays and hats were delivered to the districts. I

- 1 have more here. The first place awards will be awarded
- 2 here after this report. I must say the votes were very
- 3 close and all entries are beautiful and all entries did
- 4 get at least votes, so it was very difficult to
- 5 determine our places. Thank you all for your hard work.
- 6 For you are to be commended.
- 7 I could go on and on shouting out the amazing
- 8 work done by our districts and units promoting the Poppy
- 9 program. I have only one thing to say. Thank you for
- 10 all you do to support our organization, our veterans,
- 11 and their rehabilitation. As the saying goes, it takes
- 12 a village to raise a child. This is also true for the
- 13 American Legion Auxiliary and our programs. It takes
- more than one person to get it done. Together we can

- 22 and the other is in Los Angeles County. Both
- organizations focus on helping the homeless and
- 24 near-homeless veterans.
- 25 They also have other programs that focus on

- 1 improving the veterans' lives after serving our country
- which include suicide prevention, substance abuse,
- 3 healthcare, mental health, and PTSD.
- 4 In early May I had training for incoming
- 5 Department Presidents. Trish Ward, the National
- 6 President Elect, was our trainer. She enthusiastically
- 7 shared our goals for the '24-'25 year. One of them is
- 8 membership. While her goal is daunting, it is possible.
- 9 She has, in her words, lit a fire under the Western
- 10 Division ALA to reach a goal that is 10 percent higher
- 11 than this past year. Ooh, I'm sweating already.
- 12 She even named the Western Division "Fire."
- 13 Other divisions have other names such as "Earth" and
- 14 "Moon." We're "Fire." So be prepared to show her that
- 15 California is ready and we will meet the challenge.
- 16 Last year I spoke about how every day we hear on
- the news about threats either from Russia, North Korea,
- 18 China, and other countries. And what are we going to do
- 19 to help our military and their families if war breaks
- 20 out. I am sure the deployed personnel will have a
- 21 little less stress as they fight for our country if they
- 22 know that the ALA is taking steps to provide for their
- spouses and the children left behind.
- It is my intent to form a Military Support
- 25 Committee. Please let me know if you'd like to be on

- 1 that committee.
- 2 Let's see. Glenda was successful in improving
- 3 communication between Zoom meetings, and these Zoom
- 4 meetings have improved our communication; therefore, it
- 5 is my intent to continue.
- 6 Now I'd like to introduce my husband.
- 7 (Applause.)
- 8 DEPARTMENT PRESIDENT ELECT HAYES: And believe me
- 9 he is my support team.
- 10 Now I think I've got this next part somewhere
- 11 else to introduce other officers and I left my list, but
- 12 I have --
- 13 INSTALLING OFFICER CHRISTNER: Your officers are
- 14 already up here and are installed.
- 15 DEPARTMENT PRESIDENT ELECT HAYES: Okay. And it
- 16 says Bonnie to come to the podium to call out their
- 17 names.
- 18 INSTALLING OFFICER CHRISTNER: Yeah, that's -- so
- 19 am I done? Let's do the gifts. Okay.
- 20 DEPARTMENT PRESIDENT ELECT HAYES: Okay. I know
- 21 what I'll do.
- 22 INSTALLING OFFICER CHRISTNER: Introduction of
- 23 Department Officers and District Presidents. Somebody
- 24 flipped this over here. Are there any presentations for
- 25 our Department President?

- 1 Our Department Gopher Dennis Fercho.
- 2 (Processional.)
- 3 PDG FERCHO: I would have the Madam President
- 4 call her husband up to the podium.
- 5 INSTALLING OFFICER CHRISTNER: He's right here.
- 6 PDG FERCHO: I know. Richard, empowered to you
- 7 is the gopher. It's got pants on, but the shirt was
- 8 taken because the last president.
- 9 JUNIOR PAST DEPARTMENT PRESIDENT SCHULTZ: I took
- 10 the shirt.
- 11 PDG FERCHO: There is an outfit in here you can
- 12 try later for the gopher here. And let me just set this
- down. Let me see it. Always make sure its batteries
- 14 are charged.
- DEPARTMENT PRESIDENT GOPHER HAYES: Oh, he
- 16 answers.
- 17 PDG FERCHO: It's from the scene Caddy Shack.
- 18 DEPARTMENT PRESIDENT GOPHER HAYES: I don't know
- if I'll play that.
- 20 PDG FERCHO: You need to test the batteries all
- 21 the time. It has that. And then hold on. Too many
- 22 pockets. Sorry about that. So here. Thank you and
- congratulations.
- 24 (Applause.)
- 25 INSTALLING OFFICER CHRISTNER: Department

- 1 President Linda, I believe you have a little -- oh, I'm
- 2 sorry. Are there any more presentations for Madam
- 3 President Linda?
- 4 Okay. Madam President, I believe you have a
- 5 presentation to give our Past Department President
- 6 Glenda.
- 7 DEPARTMENT PRESIDENT ELECT HAYES: Yes. Glenda,
- 8 please come up. I have this gift to give Glenda from
- 9 all of us. And I'd like to -- we did have a little
- 10 mishap, I guess. I asked what does Glenda like, and I
- 11 was given three answers: expensive jewelry, steak, and
- 12 chocolate. So I did get her chocolate, but I thought
- the money was better than that so that she can use it.
- 14 The only problem, Glenda --
- JUNIOR PAST DEPARTMENT PRESIDENT SCHULTZ: You
- 16 didn't put it in there.
- 17 DEPARTMENT PRESIDENT ELECT HAYES: No, it's in
- there. It's just the chocolate came melty in the hot
- 19 weather. But it will still taste good.
- 20 JUNIOR PAST DEPARTMENT PRESIDENT SCHULTZ: It may
- 21 have to go back to The Legion.
- DEPARTMENT PRESIDENT ELECT HAYES: Okay. I'd
- 23 like to clarify that this is from all your Chairmen and
- 24 Officers and District Presidents and those of us who
- love you.

- 1 JUNIOR PAST DEPARTMENT PRESIDENT SCHULTZ: Thank
- 2 you, thank you, thank you. And thank you to all of my
- 3 Officers and Chairmen for being so gracious. I love you
- 4 all. Thank you.
- 5 (Applause.)
- 6 INSTALLING OFFICER CHRISTNER: Do we have any
- 7 further presentations for Past Department President
- 8 Glenda?
- 9 Okay. I'm going to do the introduction of
- 10 Department Officers and District Presidents. District
- 11 Presidents -- are we just going to have them come up and
- 12 line up? Do you have their gifts?
- DEPARTMENT PRESIDENT ELECT HAYES: Yeah, it's in
- that wagon. I have a box of envelopes in that wagon.
- 15 In the meantime while we're getting that, will the
- 16 District Presidents line up by District. Okay. Marcy's
- 17 got it. Up here on stage.
- 18 INSTALLING OFFICER CHRISTNER: Here's your
- 19 districts right here.
- 20 DEPARTMENT PRESIDENT ELECT HAYES: Okay. Put
- 21 them on the table for now. Thank you. The gifts are in
- 22 your packets. I'm going to give you your packets and
- your gift at the same time. Okay. District 2. Okay.
- 24 District 4. She's not here. District 5. District 6.
- 25 District 7. District 8. District 9. District 10.

- 1 District 11. District 12. District 13. District 14.
- 2 District 15. District 17. Oh, 16. District 17.
- 3 District 18.
- 4 INSTALLING OFFICER CHRISTNER: District 18.
- 5 Where is 18? Shame on her.
- 6 DEPARTMENT PRESIDENT ELECT HAYES: District 19.
- 7 I know that District 20 girl. District 21. District
- 8 22. We're cooking it now. District 23 is up here.
- 9 District 24. Twenty-five. I'm sorry. District 26.
- 10 District 27. Bad girls, you all went home. District
- 11 29. Where's 28? We collected it already. District 29.
- 12 And District 30, they're not here. I'm going to ask --
- 13 INSTALLING OFFICER CHRISTNER: Sorry.
- 14 DEPARTMENT PRESIDENT ELECT HAYES: That's all
- 15 right. Okay. I'm going to ask about five of my
- 16 district people to come up and get the pins out of the
- 17 wagon. And the Department folders are the Chairman
- 18 folders.
- 19 INSTALLING OFFICER CHRISTNER: We don't do that
- 20 until we close the convention.
- 21 DEPARTMENT PRESIDENT ELECT HAYES: Okay.
- 22 INSTALLING OFFICER CHRISTNER: This is you, Madam
- 23 President, right here. Department President Linda ask
- 24 Department President back to the podium.
- DEPARTMENT PRESIDENT ELECT HAYES: Okay. All

- 1 right. Will the Honorary Past President Glenda join me
- 2 at the podium. At this time I will return your gavel to
- 3 you to close your convention.
- 4 DEPARTMENT PARLIAMENTARIAN BIGGS: Get your mic
- 5 close so we can hear you crying.
- 6 JUNIOR PAST DEPARTMENT PRESIDENT SCHULTZ: I just
- 7 want you all to know that from the bottom of my heart I
- 8 truly, truly have been so honored this year and felt so
- 9 supported and have never felt so much love from so many
- 10 people. And for all of you that have come to me with
- 11 your comments and your thank yous, you never will know
- 12 how much that meant to me or how much it still means to
- 13 me.
- And it's extremely difficult for me to walk away
- from this, I want you to know that, so I truly hope that
- 16 you still will give everything that you gave me to our
- 17 new President Linda. She is a wonderful, wonderful
- woman.
- (Applause.)
- 20 JUNIOR PAST DEPARTMENT PRESIDENT SCHULTZ: And is
- 21 so deserving of this. So I thank all of you for what
- 22 you've done for me and please continue to do it for her.
- Thank you.
- 24 (Applause.)
- 25 JUNIOR PAST DEPARTMENT PRESIDENT SCHULTZ: Is

- 1 there any further business to come before this meeting?
- 2 (No response.)
- 3 DEPARTMENT PRESIDENT SCHULTZ: If not -- well, I
- 4 don't think Madeline is here, but -- oh, I didn't see
- 5 you. Madeline will offer prayer.
- 6 HONORARY CHAPLAIN LEE: Dear Father, as we close
- 7 this 2023-'24 convention year, we give thanks to our
- 8 President for a wonderful awesome year. We thank you
- 9 that we have had the opportunity to come together. We
- 10 are grateful for this time of work and fellowship. We
- 11 pray that what we have done has been for the betterment
- 12 of those we serve.
- As we prepare to leave each other to go our
- separate ways, we pray once again for those who serve
- our country that they may return safely to their loved
- ones. Now Dear Lord, keep us in your grace and be with
- 17 us until we meet again. Amen.
- 18 DELEGATES: Amen.
- 19 JUNIOR PAST DEPARTMENT PRESIDENT SCHULTZ: Until
- 20 we meet again let us remember that our obligations to
- our country can only be fulfilled by the fateful
- 22 performance of all duties of citizenship. Let service
- to the community, state, and nation be our main
- 24 objective of the American Legion Auxiliary and its
- 25 members. Let us ever be watchful of our organization

ı	and ourserves. For nothing shall swerve us from the
2	path of justice, freedom, democracy, and loyalty.
